

OFFICIAL RULES OF THE VANTAGE CREDIT UNION CASH FOR CONCERTS DRAWINGS 2024

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Vantage Credit Union Cash For Concerts Drawings 2024 ("Drawings") are open to all individuals age 18 years or older at the time of entry, who are legal residents of Missouri or Illinois. Vantage Credit Union ("VCU") and subsidiary Board, Supervisory Committee and staff members and their immediate families are not eligible to win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws" or by current marriage, adoption, or cohabitation, and any other persons residing at the same household whether or not related. All potential winners are subject to verification before any prize will be awarded.
