

OFFICIAL RULES OF THE VANTAGE CREDIT UNION 2025-26 LINDENWOOD UNIVERSITY ATHLETICS PREMIUM PRIZE DRAWINGS

The Vantage Credit Union 2025-26 Lindenwood University Athletics Premium Prize Drawings ("Drawings") are open to all individuals age 18 years or older who reside in Missouri or Illinois at the time of entry into the Drawing. Vantage Credit Union ("VCU") and subsidiary Board, Supervisory Committee, staff members, and their immediate families are not eligible to win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws" or by current marriage, adoption, or cohabitation, and any other persons residing at the same household whether or not related. By participating in the Drawings, each entrant warrants that he or she meets the eligibility requirements and agrees to receive email communication and offers from VCU and their wholly owned subsidiaries at the contact information provided on the official entry form. Each entrant fully and unconditionally agrees to and accepts these Official Rules and VCU's decisions, which are final and binding in all matters related to the Drawings.

All eligible entries must be submitted and received within the stated Entry Period described below. VCU is not responsible for lost, damaged, or misdirected entries. Winners will be notified via email by the date listed above for the Entry Period. If a winner cannot be contacted or has not claimed the prize within three (3) business days of notification, a runner-up will be selected and notified. Only one (1) alternate runner-up Drawing will be held, after which the prize will remain un-awarded. All selections are final. If requested, winners must submit an affidavit of eligibility. Prize is non-transferable.

Tickets will be issued electronically via tickets.com, delivered via email from the Lindenwood University Athletic Ticket Office and redeemable on the day of the awarded game or on the make-up date if game is postponed. Winners must have a valid email address to receive and claim the tickets. Parking, travel and accommodations not included and are the sole responsibility of winner and guests. Winner and guests must abide by all venue policies. Minors must be accompanied at all times during the game by minor's parent or legal guardian. Lindenwood University reserves the right to revoke full or partial prize from any winner or winner's guest who it and/or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring VCU and/or Lindenwood University into disrepute.
